



TreeTime Rebate (Pilot Project)

The WIWD will be implementing a pilot project for an additional tree program for spring 2025 plantings. As our district has expanded to include portions of the Rural Municipalities of Rockwood and Portage la Prairie, as well as the community of Homebrook Peonan Point, the WIWD will be running a pilot project for a rebate program to all residents in the WIWD in an effort to provide fair program accessibility to everyone.

- A maximum \$80.00 rebate will be issued to successful applicants.
- Programming is based on a first come first serve basis, rebate forms will only be accepted with an accompanying copy of the purchase RECEIPT and PACKING SLIP (the slip that will be included in the order when delivered).
- All residents within the WIWD boundaries are eligible to apply (contact the WIWD to ensure you are within the boundaries). One rebate per resident/household per year.
- Businesses are not eligible to apply.
- Planting location must be within WIWD boundaries.

STEP 1: Order your trees from TreeTime.ca in November of 2024

- There is a wide selection of varieties to choose from, with lots of fruiting varieties available. ***ensure variety is suited for your area (WIWD boundary area is zone 3)**
- You can choose your delivery date, and your order is shipped directly to you (or your P.O. Box) in the spring of 2025

STEP 2: Wait for your trees to arrive.....

STEP 3: Plant your trees! (save your packing slip that comes with your trees!)

STEP 4: Fill out the TreeTime Rebate Form. Submit your completed rebate form along with a copy of the RECEIPT and PACKING SLIP that comes with your order, to the WIWD office via mail, fax, email or in-person.

*The WIWD will issue a cheque in the amount of a maximum \$80.00 rebate to successful applicants.

Terms & Conditions

1. Trees must be ordered through TreeTime.ca between November 1st, 2024 and June 30th, 2025.
2. Planting location must be within the West Interlake Watershed District (WIWD) boundaries.
3. Completed rebate form, accompanied by a copy of the RECEIPT, and PACKING SLIP (will be received with your order of trees when delivered, stating what trees were packaged and delivered) must be submitted to the WIWD to receive the rebate.
4. **The WIWD will issue a rebate up to a maximum \$80.00 for trees/shrubs purchased through TreeTime.ca, covering the cost of the trees/shrubs and any applicable PST, will not cover any additional costs such as shipping.** The WIWD will issue and mail a cheque in the amount of the corresponding rebate to successful applicants (ensure your mailing address provided is complete and accurate).
5. Limit of one (1) TreeTime rebate per household/resident per year. (Applicants are eligible even if they have participated in other WIWD programming.) (Businesses are not eligible.)
6. Rebates to be distributed on a first come first serve basis. Program is subject to available funds, and may be discontinued without notice.
